SANDS CLOSES IT'S DOORS FOR GOOD



Saturday, November 11th, 2006 was the final day of operation for the legendary Sands Hotel Casino after a 27-year run.

Unable to stay competitive with the newer mega-facilities in town, the 2nd smallest casino in Atlantic City closed it's doors forever and the entire building will be demolished to make room for a huge new \$1.5 billion mega-resort to be built by Pinnacle Entertainment on the space now

occupied by Sands and the adjacent vacant parking lot that was once the site of the old Traymore Hotel.. A restaurant and pawn shop on Pacific Ave. currently located in front of the present Sands building have been purchased and will also be demolished to provide a huge single building site for the new planned mega-property from the Boardwalk to Pacific Ave.

Demolition of Sands Hotel & Casino is expected to begin in late 2007. The new un-named facility is not expected to open until 2010.

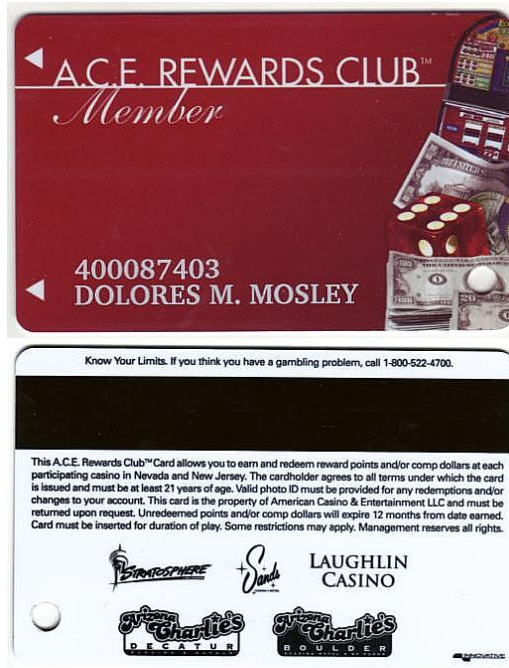
On Monday, November 27th, this \$25 Thanksgiving Day chip was issued

CHECK OUT THIS A.C.E. SLOT CARD!



A.C.E. (Atlantic Coast Entertainment) is the name of Carl Ichan's holding company that has owned Sands in A.C. for the past several years and was

intended for use in all of Ichan-owned properties.

I picked up a few of these slot cards during my trip to the Palms Show in early November and purchased several more from a Nevada card collector. This particular card was issued at the new "Aquarius Hotel & Casino" in Laughlin (which used to be the Flamingo Hilton). If you will note the 2nd line of text on the reverse of the card, it states; "This A.C.E. Rewards Club Card allows you to earn and redeem reward points and/or comp dollars at each participating casino in Nevada and New Jersey." Below the text section, in the center of the card, is the logo of Atlantic City Sands ... which is now closed. All of the casino logos pictured on the reverse of the slot card are Carl Ichan properties, which makes this card an Atlantic City issue as well. The card was only out for a few weeks before Sands closed its doors forever.

The newer A.C.E. card presently in use that was just issued, which has replaced the older card; has the Sands logo removed and "Laughlin Casino" has been replaced with "Aquarius".

I will be mailing out this tough-to-locate card to my new issues subscribers only who are currently signed up for A.C. slot cards.

STEEL PIER CLOSED!
