**HUGE CONTROVERSY IS
BREWING OVER TAJ
MAHAL CHIP RELEASE...
BELOW IS THE FACTUAL
STORY.**

The most popular and controversial
question on the A.C. message board
being probed recently is “*who’s got the
\$25’s?*” In a surprise chip release that
took place during my trip to the Palms

Casino Collectibles Show in Las Vegas
in early November, Taj Mahal released
500 Sheryl Crow nickels and 500
Gloria Estefan nickels, plus only 100
quarters for each of these popular
performers, making this issue one of
the least number of \$25 chips ever
issued in A.C. Needless to say I was at
a big disadvantage, being in Vegas at
the time of the release.

However, contingency plans made
before I left NJ bore some limited fruit
... although nowhere near what I
needed to supply my new issue
subscribers.

Much has been written in anger and a
smear campaign on the AC website
message board has mounted about
these chips ... unfortunately, most of it
is very misleading and inaccurate.
Here’s the real story;

I left monies with local friends (whose
names are not relevant for the purposes
of this report ... but it was not Mike
Custodio) in the event that Trump Plaza
released their \$25 lenticular Halloween
chip while Brenda and I were away in
Las Vegas.

I picked up Dick’s phone and had a short conversation with Mike who told me that Taj had just released the Sheryl Crow and Gloria Estefan \$5 and \$25 chips. This was a complete surprise to me. I was aware that the chips were in the works ... but I had no idea when they were going to be released. In fact, I thought that they would not be released until later in the month.

At any rate, after I said goodbye to Mike, I immediately called my friends back in NJ who were holding my money for the anticipated \$25 Trump Plaza Halloween chips and asked them if they could get over to the Taj as soon as possible and purchase whatever chips they could off the table. When they got to A.C. a short time later, there were a few chips on the table and they did not see anyone around buying any. They asked the pit boss for a fill and about an hour later additional chips were delivered to the table. No limits were placed on how many chips they could purchase so they split up the advance monies I had left with them and they purchased as many \$5’s and

\$25’s as the casino supervisor would allow them to and left. They were on the property for approximately an hour and a half and saw no other chippers ... except for one person named Joe as they were leaving ... and they sold something like 3 of each chip to that individual.

Mike Custodio has been unfairly and inaccurately accused and severely grilled on the A.C. message board by another club member, as the one who has possibly gobbled up all of the \$25 chips ... or had two alleged accomplices with him when he made his usual chip purchase for his friends and co-workers. The truth of the matter is that I wound up with 35 of each of the quarter chips through sheer luck and happen-stance ... even though I was in Las Vegas at the time... and the two gentlemen who were observed with Mike, were not the two kind people who picked up chips for me as a personal favor.
